Ray Sturdy, Membership & Chapter Development

George Burkett, VP Program Activities

- George reminded the Board about the Bush League Quartet Competition to be held in Gaylord on Friday, August 20, 2010 and Saturday, August 21, 2010.
- George provided information about the fall convention and contest to be held in Grand Rapids on Friday, October 15, 2010 through Sunday, October 17, 2010. It was recommended by Mike Matson that our members register with our chapter, rather than on-line. This will allow for an easier refund, if necessary.
- George was thanked by the board members for a great chapter picnic, held on Monday, July 12, 2010.

Mike Matson, Treasurer

- Mike reported that we have an end of the month Grand Total of \$9,600.96 in the Funds Available account, and of that amount, \$4,120.41 is in the operating funds.
- Mike mentioned that the quartet, **Resisting –A–Rest**, was very appreciative of our \$100.00 donation towards their 2010 International Convention participation.

Old/New Business

- Dave Kemp asked for the **Power Play** quartet song that the chorus will be singing in the 2011 Show. Jim shared that the song will be <u>*Time After Time.*</u>
- Dave Montera discussed the monetary support that is being requested by the nine students from Northville High School in order for them to attend the Harmony Explosion Camp at CMU in August. It was moved by Mike Matson that our chapter treasury match funds (up to \$900.00) of the contributions donated by our chapter members; Second: Jim Kunz. Motion carried.
- Lou Stark discussed the possible need for a shuttle bus from the chapter hotel to the competition venue for the 2010 Fall Convention to be held in Grand Rapids. Dave Montera volunteered to investigate the possibility of our chapter renting a shuttle bus for transportation during the day of competition.
