Ray Sturdy, Membership & Chapter Development

Jim Kunz, VP Music & Performance

- Jim reported that the Music Team had a meeting on June 7th. He reviewed the minutes from that meeting with the board members.
- Jim reviewed the 2011 Show planning repertoire and provided a narrowed down list of eleven show songs.
- Jim noted that the Music Team also discussed a Saturday matinee performance, followed by a Saturday evening performance, in an effort to attract a new group of patrons. - Jim reported that the Music Team also discussed the need to provide consistent orientation to our new members and recent guests.
- Jim noted that the Music Team discussed the need for additional coaching, possibly with Matt Combs.
- Jim will be coordinating with Tom Uicker and Rick Vuylsteke re: the number of copies of new music needed to purchase for the 2011 show.

George Burkett, VP Program Activities

- George reported that we have a performance at the Heritage Village Park Place at 1:00 PM on Saturday, June 26th.
- George provided instructions and directions for the annual DOC picnic to be held at Boulan Park on Monday, July 12th, from 4:00 PM – 10:00 PM. George is in the process of inviting the Grosse Pointe Chapter and the Pontiac-Waterford Chapter.

John Balint, VP Marketing and PR

John reported that he has been in contact with Jim Martin at Henry Ford Village regarding a 2011
Spring performance. Discussion took place about this time frame and it was suggested that we
perform after the Greenfield Soup and Salad performance, which is usually held in the beginning of
March, and before the annual Pioneer District April competition. John will send a letter to Henry Ford
Village requesting a date between these two performances.

Mike Matson, Treasurer

- Mike reported that we have an end of the month Grand Total of \$10,322.96 in the Funds Available account, of that amount, \$4,298.77 is in the operating funds.
- Discussion was held regarding which account funds we should use for the approved donations to the competing Pioneer District chorus and quartets in the 2010 International Competition. It was decided that we would use funds from the "Other Charities" account.

Old/New Business

- Discussion took place regarding the authorized donation to the 2010 International Competition Pioneer District guest quartet Resisting-A-Rest as noted in the May 2010 minutes. After discussion, it was decided to approve the \$100.00 donation.

- Lou Stark questioned the need for additional chorus coaching when we have Dave Beamer and others
 in our chorus who provide chorus coaching. Discussion took place regarding the need for a style coach
 and the monies needed for visiting coaches. It was noted that we have \$1300.00 budgeted for chorus
 coaching. Jim mentioned that the Music Team will continue to work on this issue.
