### Jim Kunz, VP Music & Performance

Herb Hebner – Immediate Past President

- Jim reported that the Music Team held a meeting on October 1, 2012. Jim shared a short summary of that meeting:
  - 1) 2013 Annual Show planning The Music Team: a) recapped the status of the 2013 Show Songs; b) announced that oral approval has been given to the quintet "Full Throttle" (contract not yet signed); c) the Music Team has decided to request a bid from "Hot Air Buffoons"; d) reviewed the "in-house quartets" and the songs they will be performing and have asked these quartets to audition their song for the Music Team and/or Chapter by November 19th; e) discussed the need to develop a script scenario and the design and construction of scenery flats (Roger Boyer and Herb Hebner are working on ideas for a stage set); and f) have decided to title the 2013 Show "DOC Does Doo-Wop", with Ken Casey as our emcee.
  - **2)** 2012 "Fall Contest": The Music team discussed preparations regarding coaching, stage presence, chorus member expectations, and the Saturday rehearsal on October 6<sup>th</sup>.
  - **3)** The Music Team discussed additional fund raising opportunities. Dave Kemp provided information regarding the fund raising vehicle "Great Lakes Scrip".
  - **4)** The Music Team will be developing a song list and script for the performance at the Henry Ford Village sing-out to be held on Sunday, November 4, 2012.
  - **5)** The Music Team decided that we will not be performing at the Greenfield Soup and Salad event this spring.
  - **6)** The Music Team discussed the possibility of re-establishing a Chapter Ensemble. After discussion, the Team concluded it was not necessary to establish the ensemble before the February 2013 Show.

### Pete Peters, VP Programs

- Dave Montera also reminded Board Officers that they each need to present a 2013 Budget as soon as possible.
- Dave Montera updated the status of our request for a Hospitality Room in the McCamly Hotel during the 2012 Fall Convention. After discussion, Dave announced that DOC will not be having a Hospitality Room at this event.
- David Kemp introduced and discussed with the Board the possibility of participating in the fund raising organization called "Great Lakes Scrip".
