#### Mike Matson, Treasurer's Report

- Mike reported that we have an end of the month Grand Total of \$15,942.72 in the Funds Available account, and of that amount, \$6,536.78 is in the Operating Funds.
- Mike mentioned that we received a letter of acknowledgement from the Harmony Foundation for our three donations in memory of recently deceased members.

## Joe DeSantis, VP Programs

Joe reported that he is beginning to work on the 2013 Annual Chapter Picnic and will extend an
invitation to the Sweet Adelines Shoreline Chorus. Joe will have more to report re: picnic preparations
at next month's meeting.

## **Old/New Business**

- Dave Montera shared the proposed 2014 Annual Show Budget. After discussion, it was moved by Jim Kunz, seconded by Joe DeSantis, that we approve the 2014 Annual Show Budget. Motion carried.
- Mike Matson made the Board aware that he has received the insurance bill re: liability/accident and property damage coverage. Mike mentioned that the bill is covered in our 2013 Chapter Budget.
- After discussion, Jim Kunz moved, seconded by Herb Hebner, that we donate \$300 to the Pioneer District International Chorus representative, and \$100 to each qualifying Pioneer District Quartet representative, the total donation being no more than \$800.00. Motion carried.
- After discussion, *Mike Matson moved, seconded by Joe DeSantis, that we donate \$500.00 to the 2013 Harmony Camp Explosion. Motion carried.*
- After discussion, Jim Kunz moved, seconded by Herb Hebner, that we make a \$75.00 donation to the Harmony Foundation in memory of past Chapter member, Reed Abt. Motion carried.
- After discussion, Jim Kunz, seconded by Joe DeSantis, moved that we make a \$75.00 donation to the Harmony Foundation in memory of Paula Kaiser, father of Chapter Member Paul Kaiser. Motion carried.
- Jim Kunz and Joe DeSantis introduced and discussed the possibility of resurrecting the "Jug Night Event".
