#### Jim Kunz, VP Music & Performance

• Jim shared a short summary of the Music Team meeting held on December 1, 2014:

4) New Business - a) Sue Gleason is scheduled to be with us at our Chapter meeting on the 15th of December;
b) The singing engagement at the Detroit Zoo was a great success; c) We agreed to survey the members regarding an Oakland County Board of Commissioners performance on January 14, 2015; d) The Team talked about the need for a planning session/retreat/discussion with our members re: the information collected during the recent survey; and e) The Team discussed the recent decrease in our membership and the need to make some changes, both for the benefit of our current members and to better serve our future guests/members.

#### John Balint, VP Marketing & PR

• John reported that we have a potential performance in April 2015 at the Walled Lake United Methodist Church and will give the information to the Music Team.

### Roger Boyer, VP Membership & Chapter Development

• Roger mentioned that the Royal Oak Outreach Committee met a couple of weeks ago and is moving forward with ideas of how our Chorus can be more involved in the Royal Oak community. The Committee will schedule another meeting sometime after the New Year. It was suggested by Board members that Roger investigate the

possibility of "Singing for Seniors" and singing at the Imagine Theatre. Roger also mentioned that he will contact the Royal Oak Farmer's Market for possible singing engagements.

• After discussion, Roger Boyer moved the following motion: Having been voice-tested and approved by the Music Team, Jim Ryan is recommended for membership into the Detroit-Oakland Chapter of the Barbershop Harmony Society. Motion seconded by Terry Webner. Motion carried.

## Mike Schulte, Treasurer's Report

- Mike reported that we have an end of the month Grand Total of \$11,977.77 in the Funds Available account, and of that amount, \$2,718.20 is in the Operating Funds.
- Jim Kunz suggested that each Officer present budget line items in order to create our 2015 Budget and send those amounts to Dave Montera.
- After discussion, it was asked of Mike to move the Canada Night raffle proceeds into the Harmony Foundation budget.
- The Board accepted the November 2014 Treasurer's Report for information purposes.

### Old/New Business

- Dave Montera is in the final stages of securing a contract with O.C. Times and BackBeat for our 2015 Annual Show.
- Dave thanked those members who were part of the Nominating Committee during the election of our 2015 Chapter Officers.
- Dave Montera will be consulting our By-laws re: ex-officio guests and possible voting privileges of ex-officio guests, etc.
- After discussion, it was moved by Michael Kramb that we approve a total donation of \$1500.00 to the Harmony Foundation. Seconded by Jim Kunz. Motion carried. Furthermore, it was moved by Jim Kunz that we move \$1000.00 from the Other Charities fund, into the Harmony Foundation funds. Seconded by Michael Kramb. Motion carried.
- After discussion, *it was moved by Mike Matson that we donate \$100.00 to Rolls Voyce (the Pioneer District Senior Quartet Champions) for the 2015 Mid-Winter Convention. Seconded by Roger Boyer. Motion carried.*
- Steve Sutherland, Dave Montera, and Jim Kunz have been discussing the recent survey results and would like to schedule a meeting with the Chapter members in order to discuss at length their findings. After discussion, it was decided that Dave will provide possible dates to the Chapter members, and choose the one that most members can attend (12/22/14, 1/12/15, or a Saturday in December or January).
- Dave thanked the outgoing Board members for their dedication and service to the Chapter during 2014.
