The Board received for information purposes a report from D. Montera with a proposed show budget for the Fall, 2016; included Proposed Budgets and Actual Income /Expenses for the years 2016 (Spring), 2015 and 2014 (See attachment). The Feb., 2016 realized a profit of \$6688.

Montera moved and Paul seconded a motion including the following recommendations for the Fall, 2016 Show:

-to use the City of Royal Oak for printing the program (at considerable savings from past years) totally in 4-color. The program will be utilized at all Chapter performances for a year-

a feature to be used in marketing to Royal Oak merchants to encourage their taking ads out in the program.

- -to reinstate a Groupon offer (\$100 for Groups)
- -to request use of the Royal Oak Middle School auditorium (rather than the High School) for the show with six choral risers requested
- -to skip the post-matinee lunch (and the attendant expense of \$250 to the RO School District)
- -to purchase one street banner (to be hung on Main St.) at a cost of \$350.
- -to use Pasquales for the after-glow but only if they will commit to staying open until 1 AM.
- Given the projected profit of \$3,350 (the lowest profit in recent years) we will either need to sell more tickets to the show or seek other sources of income.

The Music Team is working on a Show Title.

D. Montera is looking into acquiring new short sleeve chorus shirts.

Harmony Mercenaries-

After discussion regarding the lack of time the chapter has to commit to rehearsal, the added cost for the purchase of music rights and CD production, it was decided that DOC would make no formal commitment to participate in a south-east MI Mercenary group. However, individuals in the chapter could participate on an independent basis.
