Old Business- K. Opal

M. Matson reported that the Chapter needs to decide whether to provide additional Jug Fund support for the two additional Senior quartets that will be going to the Mid-Winter convention (noting that Jug funds have already been allocated in support of three quartets and one chorus going to Midwinter).

M. Matson moved and G. dAllemand seconded a motion to allocate \$600 for each of the two Senior quartets going to Mid-Winter. Funds to be taken from the "Other charities" Fund. Motion carried.

D. Montera made a contribution to the chapter and suggested that it be used in part to support the two additional Sr. quartets Mid-Winter expenses.

The future of the Jug Fund Night was discussed. First, there will need to be a replacement for J. DeSantis as chair. Alternatives to supporting an alternative to Jug Night were discussed:

- -having a Winter and Fall Jug Night (the Fall night to be sponsored by another chapter, perhaps in the western part of the district).
- -splitting the Jug Fund receipts from Our Jug Night in two (Half for any chorus reps and half for any quartet reps)
- -other alternatives including supporting Jug Fund Shows where the talent, venue, etc. expenses are donated and the show tickets are donations.

Selected officers have received from BHS a survey to be completed regarding general questions about chapter operations and the "Everyone In Harmony" initiative. The intent is for there to be a single "consensus" response from each chapter. K. Opal will set a time for the Board to meet to respond to the survey (due mid-December, 2018).

New Business- K. Opal

J. Paul submitted a letter of resignation as Music Team VP. The resignation was accepted by the board. J. Kunz was appointed by President Opal to complete J. Pauls 2018 position as Music & Performance VP.

The Chapter needs to create a new email account or accounts (information, ticket sales, "hire us, etc.) and designate an individual (likely the chapter secretary) to monitor the account. J. Kunz can help to set up the account.

Grosse Pointe Chapter Merger- K. Opal will organize a committee of Board members to meet with GP members to resolve numerous questions (who surrenders their charter, rehearsal venue, chorus name change, etc) regarding a merger.
