The meeting was convened at 6:33 PM by President DeSantis.

J. Kunz moved and G. d'Allemand seconded a motion to approve the meeting minutes from May 17, 2021. Motion carried.

Treasurers Report: J. DeSantis: M. Schulte forwarded the report to President DeSantis who will post it later.

Music Team Report: J. Kunz: The Music Team met (zoom) on June 7, 2021 and discussed the results of G. d'Allemand's survey and set July 19 as a face-to-face rehearsal at the Royal Oak Picnic Shelter.

Chapter Development & Membership: G. d'Allemand: Geoff presented the results of the survey: 26 responses with 22 members stating that they were ready to meet face-to-face again and 4 members indicating that they were not ready to meet face-to-face again. The consensus opinion was that members wanted to meet face-to-face if safety was assured. Program Report: G. Burkett: George discussed the possibility of scheduling a chorus picnic at Sylvan Lake. A tentative date was set for August 16. Pete Peters will secure the Sylvan Lake venue.

Old Business: J. DeSantis: The sale of risers to City Lights is complete and a donation was sent to Harmony foundation in honor of Bob Kramb.

New Business: J. DeSantis: There was extended discussion regarding any requirements for members attending face—to-face rehearsals since July 19 will be

our first one since the onset of the Covid pandemic. The basic notion is to ensure the safety of the members but to be the least restrictive as to prohibit members from participating.

It was decided that J. DeSantis would send an email to all members to encourage (but not require) members to wear a mask.

In light of that recommendation, the Board decided to have Sally Montera make 30 singing masks at a cost of \$15/mask. The masks will be available for all members at the July 19 rehearsal.
